## C.R. 22.23.06 In Support of Mid-Semester Student Rating of Teacher Effectiveness

- *Whereas,* The Council of Commonwealth Student Governments (CCSG) represents the concerns of the students attending the campus in matters of a University-wide nature, as well as those issues impacting the combined interests of the campuses, and
- Whereas, The Pennsylvania State University and The Council of Commonwealth Student Governments recognize that students have the right to a quality education delivered in a way that accounts for and reflects their learning needs. According to Penn State's 2016 2025 Strategic Plan, Penn State is "well situated to provide opportunities for students to pursue education in a manner and context that best meets their varied needs"<sup>(1)</sup>, and
- Whereas, As part of the University-wide strategic plan's commitment to transformative education, Penn State established goals of fostering "a culture of respect and inclusion that values the experiences and perspectives of faculty, staff, and students"<sup>(1)</sup>. The University commits to evaluating and rectifying "organizational structures, policies, and practices that cause differential impact and limit access and opportunities for faculty, staff, and students at Penn State"<sup>(1)</sup>, and
- *Whereas,* Student Rating of Teacher Effectiveness (hereto referred to as SRTEs) provide students with the ability to provide their perspectives on course policies and learning, and offer feedback and suggestions to improve course and instructor practices, and
- *Whereas,* In focus group interviews conducted by Penn State University, students indicated that they are more likely to submit SRTEs if the information will be used to make improvements in the course<sup>(2)</sup>, and
- *Whereas,* For traditional 15-week courses, SRTEs are offered during the last two weeks

of the semester. The traditional offering period ends on the last day of classes, and

*Be it resolved,* To ensure that student input and suggestions can be used to improve the course while it is being delivered, an additional SRTE will be administered electronically in week 7 for traditional 15-week courses.
