Whereas,	The Council of Commonwealth Student Governments (CCSG) represents the concerns of the students attending the campus in matters of a University-wide nature, as well as those issues impacting the combined interests of the campuses, and,
Whereas,	While we at the Pennsylvania State University are becoming increasingly digitized, paper documents are still necessary for many classes, as well as for student clubs and organizations, and,
Whereas,	The Paw Prints initiative was aimed at standardizing the way students can print while on campus, however this initiative removed the previous printing system's included amount of free printing, and,
Whereas,	The cost of printing can be excessive, as students already face many additional costs in addition to their tuition such as: textbooks, required access to different computer software or programs, as well as miscellaneous educational materials and,
Whereas,	Some campuses such as the Fayette and Harrisburg campuses already offer five- dollar free printing cards that are available to students on demand, to offset the cost of printing, and,

These cards can be funded by the Student Activity Fee Fund/the Student Initiated Whereas, Fee Fund, as well as other sources of funding at the campus' discretion These free printing cards can be tracked by making students fill out a request Whereas, form to obtain a card and,

These cards would be given out on a request basis at campus discretion with the Whereas, funding resources permitted and,

Be it resolved, The Council of Commonwealth Student Governments advocates for the provision of five-dollar printing cards to be made available to all students attending a commonwealth campus utilizing the Paw Prints system to ease the potentially prohibitive costs of printing, with funding allocated from either the Student Activity Fee Fund/the Student Initiated Fee or any other source that the campus deems appropriate.
